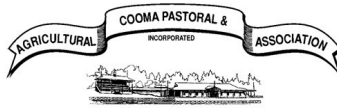

ALL COMPLETED FORMS AND PAYMENTS MUST BE RECEIVED (IN FULL) TO SECURE YOUR SITE

TERMS & CONDITIONS

1. Access to sites will be available from **THURSDAY MARCH 12TH 2026**.
2. Stall holders are responsible for their own stall safety including implementing risk migration strategies for work health and safety.
3. Ground Space applicants agree to supply a copy of their Public Liability Insurance Certificate of Currency noting a minimum of \$20 Million cover & COVID-19 Safety plan specific to your site/activity if applicable.
4. Hobbyist Stallholders can come under the Cooma P & A Show Society's Insurance cover but must read and sign the "Hobbyist Stallholders Only" declaration section provided. This comes with a small administration fee of \$15.
5. Food Vendors must supply a copy of their Food Safety Supervisor Certificate. All food vendors must have a tested and tagged (within last 12 months) fire extinguisher.
6. All leads and electrical equipment must be tested, tagged and in date for safety reasons. Any lead not tagged will be removed from site (limited power sites available).
7. Each site holder will be entitled to 2 entry passes. Prior to the show weekend (depending on size of site and cost) limited additional entry passes at a cost of \$5 per person.
8. **NO** refunds after Saturday 14th March 2026.
9. Any sites not occupied by 8am Saturday 14th March 2026, will be reallocated.

1. Full payment in full must be received by the close of business Friday 6th March 2026.
2. Payments made via Direct Deposit into our bank, please use your Site Name as the reference.

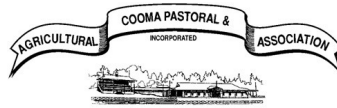
